Conformation: Jr. Handling ~ Pee-Wee, Sub Jr., Novice & Open 8-12 & 13-17. BJH, RJH, Non Reg. (divided by sex) 2-4 months, 4-6 months, BOBP, BOSP  
Altered & Intact ~ (divided by sex) 6-9, 9-12, 12-18, Novice, Am Bred, BBX, Open Blue Merle, Open Red Merle, Open Black, Open Red. WD, WB, BOW, BOS, BOB.

**AWARDS:**

Obedience: Ribbons 1st – 4th, Obedience ~HIT, Hi Jr, Hi Combined, Hi Scoring Other Breed.  
Conformation: Ribbons 1st – 4th, Rosettes and Awards for BJH, RJH, BOBP, BOSP, AWD, ARWD, AWB, ARWB, ABOB, ABOS, ABOW, WD, RWD, WB, RWB, BOW, BOS, BOB.

- ✓ All ASCA rules & regulations will apply.
- ✓ Please keep your dogs on leash and pick up after your dogs.
- ✓ Bring plenty of wind and sun protection, please stake down your canopies securely. The show site will be **OUTDOORS ON GRASS**. No electric available other than RV spots.
- ✓ Lots of trees and shade.
- ✓ All entries must be on a current ASCA entry form, found at [www.asca.org/formsandrulebooks](http://www.asca.org/formsandrulebooks). Use one Obedience form & Conformation form per weekend. All entries must be completed (with agreement signed on back) or they will be refused. Dogs 6 months & over must have ASCA Registration number on the entry form.
- ✓ No entry shall be accepted from a dog or handler disqualified from the ASCA conformation program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA
- ✓ ASCA sanctioning pending – events will be held under current rules and regulations of ASCA
- ✓ Entry fees will not be refunded if the dog is absent, disqualified, excused or barred from competition by the show committee, ASCA, the show veterinarian, the judge. HiDASC, their Boards of Directors, ASCA, its Board of Directors, and the property owner assume **NO RESPONSIBILITY** for any loss, damage, or injury sustained by exhibitors, handlers, or to any of their dogs, personal property, and/or children.
- ✓ Entry Fees will not be refunded due to acts of nature, or situations beyond our control – fire, rain, wind, loss of light or power.
- ✓ There will be a \$30 service charge on all returned checks. NSF is considered an **INVALID ENTRY**.
